4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 15.00 X Estimate High Earnings/Share 4.60 = Forecasted High Price \$ 69.00

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 24.35 X Estimate Low Earnings/Share 2.61 = Forecasted Low Price \$ 63.55

(b) Avg. Low Price of Last 5 Years 32.56

(c) Recent Market Low Price 34.61

(d) Price Dividend Will Support $\frac{\text{Present Dividend}}{\text{High Yield}} = \frac{0.080}{0.20\%} = 40.00$

Selected Forecasted Low Price 34.61

C ZONING using 25%-50%-25%

Forecasted High Price 69.00 Minus Forecasted Low Price 34.61 = 34.39 Range. 25% of Range 8.60

Buy Zone 34.61 to 43.21

Hold Zone 43.21 to 60.40

Sell Zone 60.40 to 69.00

Present Market Price of 43.49 is in the **Hold** Zone

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{69.00 - 43.49}{43.49 - 34.61} = \frac{25.51}{8.88} = 2.87$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Present Market Price}}{\text{Present Market Price}} = \frac{69.00 - 43.49}{43.49} = 1.59$ X 100 = 158.66 - 100 = 58.66 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Present Full Year's Dividend } \$ 0.080}{\text{Present Price of Stock } 43.49} = 0.00 = 0.18\%$ Present Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{6.44\%}{15.00} = 0.43\%$

C COMPOUND ANNUAL RETURN - USING FORECAST HIGH P/E
